**Important Information:**

1. A Lease Notification will only be accepted where the Owner/s & Lessee/s are current members of the IPHS or financial members of another Pinto Association within Australia. A copy of membership details must be provided if not a IPHS financial member.
2. A Lease Notification Form must be forwarded to the IPHS Office within 30 days of the "Start Date of Lease".
3. A Lease Notification Form must have indicated a "Start Date of Lease" and "Expiry Date of Lease".
4. Under all circumstances (including the issue of fines and penalties), the Lessee will be considered the responsible party.
5. The horse's original Certificate of Registration must be submitted with this Lease Notification Form. The lease details will be recorded, a Certificate of Lease will be sent to the lessee, and the original certificate will be held by the IPHS and will be sent back to the owner once the lease has expired.
6. It is highly recommended that you have a Legal Lease Agreement (contract) drawn up between both parties to prevent any legal issues at a later date.
7. Both parties must notify the IPHS in writing on early termination of the lease.
8. Incomplete applications will be returned
